- A. Identification and Validation: Post detailed investigation and analysis, below findings were confirmed by the team.
 - The data belong to 2019 period and inactive with no further interface or referencing to other system.
 - b. The data was limited to 64 row entries, wherein 44 entries were found duplicate or test data.
 - The data belong to inactive/old compliant page which was having limited attribute as captured in record.
 - d. The suspected module was not in use/discontinued since mid-July 2025.

B. Mitigation Action: Corrective and Preventive

- a. SIDBI engaged Cybersecurity Tech partner CERTIN impanelled M/s Inforpercept to provide technology and security insight into the matter along with recommendation to address gaps.
- b. Presently running controls and security updates on systems checked and confirmed.
- c. Monitoring of any suspicious traffic heightened on the system.
- d. Recommendation of best practise with reference to data accessibility applied on system.
